# Showdown at the Wapato Corral

# Weekend event started with the Knights of Pythias, who wagered that a car show would work in Gaston

THROUGHOUT MOST OF THE YEAR, PEOPLE TRAVELING ON HIGHWAY 47 CAN DRIVE THROUGH GASTON AND BARELY NOTICE IT. WITH A LAND AREA OF ONE-FIFTH OF A SQUARE MILE, AND BOASTING SUCH ATTRACTIONS AS A FEED STORE, A TAVERN AND A TIRE SHOP, THE TOWN OF 600 DOESN'T YET QUALIFY AS A TOURIST TRAP.

But for a single day each summer, Gaston becomes a destination for automobile aficionados of all stripes. Now in its 10th year, the Wapato Showdown is regarded by organizers as a tremendous success. Initially, however, they dismissed the concept as ludicrous.

"The first year, when some of the guys came along with the idea to do a car show, nobody thought people would bring their cars to Gaston," said Chris Anderson, a member of the Knights of Pythias, who organize the event

"People thought they were nuts," added fellow Knight Don Allen.

Luckily, the Knights of Pythias had an expert among them: Harold Gabriel – a lifelong automobile fanatic who had been building, restoring and showing hot rods for years – convinced them the plan was workable.

"Gabe," as he was commonly called, was able to steer the group in the right direction during the Wapato Showdown's early years. In that time, the rest of the Knights gleaned enough knowledge to carry on the tradition after his untimely death from a heart attack in 2000. "He knew what the car people liked," said Ed Yates, a member of the Knights. "He taught us what to do."

Gabe coached them about the basic ingredients that attract car show participants, such as ample room to show off their cars and plenty of grass to help mitigate the summer heat. But he also incorporated a couple of elements that are counterintuitive to conventional car show know-how.

Unlike similar events, the Wapato Showdown doesn't divide cars into categories, and doesn't rely on judges or elections to determine who gets a trophy. Instead, each of the show's 100 sponsors – a designation acquired for \$100 – picks a winner.

### No politics

"We have no classes and no voting," said Yates. "The sponsors pick the cars they like, so there's no politics involved."

The Knights say they decided to depart from the orthodox system because personal alliances and animosities can undermine the impartiality of the contest. At their show, such intrigues don't exist – champions are chosen entirely based on the subjective standards of the sponsors.

Even a beat-up 1987 Honda Civic can win if it manages to tickle someone's fancy or invoke nostalgia. As long as you're willing to show your car or motorcycle, the Wapato Showdown will be more than happy to collect your \$12 registration fee.

"It's not just hot rods and classics. If you have a brandnew Corvette off the line, you can come in and show it off," said Yates, adding that jalopies and works-inprogress are welcome, providing they can still drive onto the field.

"It doesn't need to be a perfect car," he said.

Despite the show's avant-garde attitude, organizers say car fans have embraced the Wapato Showdown. So far, only a handful of participants have complained about the trophy-picking method, open admission and lack of classes.

Meanwhile, the show has swelled to more than twice its original size, from 150 vehicles in 1997 to 350 in 2005. The number of spectators, for whom admission is free, has also noticeably increased, the Knights say.

### Knights' numbers swell

The fact that the Wapato Showdown has earned such unlikely popularity echoes the larger story of the Gaston chapter of the Knights of Pythias.

Fifteen years ago, the organization's membership had dwindled to one person. Now, it has about 45 members –

# **Tribute to a Fine Pythian**

George Richard Seymour, 104, a longtime Pythian and resident of Forest Grove community, died Friday morning, July 21, 2006 at his home. George was born in 1901 in Deadwood, South Dakota and moved with his family to Oregon when he was a young boy because his mother had heard of University Pacific and wanted her children to be educated there. During his long lifetime George worked in many types of jobs and was married several times. George's first wife Beatrice was also a Pythian. They

were married 54 years. After Beatrice passed away, George remarried more than once. George's third wife Dorothy was a member of Phoenicia Temple. At the time of his passing, George had been married to Brenda for several years.

What do you say about George? It would take another 104 years to fully describe his life. All who knew him have now lost the best friend and finest person they may ever know. He was also one of the most interesting men I ever met. Once I told him that anyone born in North or South Dakota had to be tough and that coming from Deadwood it was no surprise he was over 100.

He said he watched his father fall from the Oregon Electric Train as it lurched at the station and then crushed him. George was only 9 at the time. As the "man" of the house, he went to work early, and took most any job available. He worked the oil fields of Central and South America, high up in the construction of the buildings of the 1930 World's Fair in Chicago, and surveyed all over Alaska and Oregon. While in Chicago, he said he knew Al Capone, lived above one of his speakeasy's, and even ran one for awhile. "One day he stepped off a curb and a bullet went through his coat just missing his shoulder!" "If I was taller or had not stepped down, I'd been shot!" said George.

He also told me he was at Fort Lewis in uniform, waiting to go to France when World War I ended. One of George's last jobs was as an electrician. He always

growled because they made him retire at 65 when he said he could have worked another 20 to 25 years. Another construction job was building the Masonic Grand Lodge of Oregon here in Forest Grove. He had a sharp mind and a good memory.

During his boxing career in San Francisco, he was asked to move up a weight class and replace a "no show." Remember this was bare knuckle. "That was not such a good idea" he concluded! He remembered all sorts of jokes and could recite many things from memory. Loved to travel, go on cruises, play cards and be with people. He could recall people, places and events farther back and more clearly than anyone I have ever met.

I became acquainted with George when I was a kid about 20 years old and he was about 67, which was an old man to me. Now I am an old man and George never seemed to change. Even at 100 he could climb stairs better and faster. Nor would you want to take a poke at him for he still had his boxer's reflexes!

A longtime member of the Masonic Lodge and the Knights of Pythias, he was always active. He enjoyed hunting, fishing, walking, traveling and going on his favorite Masonic outing to the Malheur Caves. Another pleasure was gambling, especially at his favorite casino "Pucker Brush."

George and his first wife of 54 years Beatrice had two children, Richard Seymour and Ann Lindgren along with several grandchildren. His second wife died suddenly as they went to dinner shortly after they were married. Third wife Dorothy, succumbed to cancer after 10 years of marriage. His comment after "I'll never marry again" was that "the only requirement I have for a wife is that she be able to drive at night." Apparently his wife Brenda fit the bill and has also nurtured, protected and loved him for several years. She saved his life on more than one occasion and was responsible for George getting a pacemaker which gave him a few more years to be our friend


At 100 George voluntarily gave up driving, and now he has given up his life. Though he is probably saying he could have gone another 20 years.

He touched so many in various ways. His friendship, kindness, generosity, humor and love will be remembered by all who knew and loved him back. Goodbye, George, old friend.

# **Comments from OPN Business Manager** ~ Wylie Nichols

A successful year for the Oregon Pythian News publication; the accomplishments, with everyone's help, included a complete update of the mail list and maintaining cost projections.

The removal from the mail list of "Oregon Pythian" names, who have been called, and a reduction of courtesy copies improved the overall mailing; resulting in cost reduction of address correction notices by fifty (50%) percent. Overall expenditures were controlled at the cost of \$1.70 per issue for each Oregon Pythian reader. Also, the use of a slip-sheet aided in cost control.

The projected cost for the 2006-2007 term will remain at \$1.70 per issue for each Oregon Pythian reader. It is uncertain and non-determinable at this writing what postal or printing cost increases may be incurred during the year. These possible unknown cost increases should not drive the upper limit forecast beyond \$1.75 per issue for each Oregon Pythian reader; the same forecast as this year.

During last Grand sessions, I requested more stable funding from both the Knights and Sisters. The Knights responded with additional funds and the Sisters

continued the per capita support-plus donations of \$300 and \$121; Boosters were generous! Thank you, one and all, for these funds. The stable funding provided the first three issues and donations plus booster support made the fourth issue available. I request encourage vour continued financial support for the Oregon Pythian News publication.



The OPN staff has enjoyed Domain and Jurisdiction wide support and especially appreciates all of your input, through articles and photographs. We will endeavor to meet all mailing schedules, with timeliness of content and material about and for Oregon Pythians!

# **North Plains' Stink Fest Draws Throngs of Garlic Lovers**



The 9<sup>th</sup> annual North Plains Elephant Garlic Festival was held on August 11-13, 2006 at the Jessie Mays Community Center and according to Patti Burns, who chiefly organized the "stinkee" celebration over 30,000 attended the event over its three day run.

"It was perhaps the biggest stink fest ever," said Patti Burns, "the crowds were heavy on Saturday and demand for garlic offerings was in full swing. The garlic beer ran dry at approximately 7 p.m. Saturday and The Knights of Columbus with roughly 850 pounds of garlic chicken on hand, ran out around 1 p.m. Sunday. With clear blue skies and balmy temperatures, the garlic ice cream was in high demand throughout the entire festival.

The festival opened on Friday, with 20 food booths, 50 arts and crafts booths and FREE children's entertainment. As families sat under the shade and atop the hay bales lined up in front of the stage, they enjoyed music by Chuck & Dave, Love Pyle, Tom Mann & The West Coast Country Band, Stevie Marie, The Miller Brothers Genuine Blues Band and other entertainment at the Beer and Wine Garden from opening until closing. This year the second annual 10k run / 2K walk was held on Saturday at 8:00 AM with nearly 300 participants maneuvering the course. The parade began at 10:00 AM on Saturday with 32 entrants winding through the streets of downtown North Plains and ending at the festival center. Many festival goers lined up for rides through town in the horse drawn wagon.

The Knights of Glencoe Lodge operated the entire beer garden including: set-up, serving, monitoring, containment, handling receipts, expenses, tear down and clean-up.

It's a big commitment but a worthwhile endeavor with all of the proceeds going right back into the local community. # Proposed Legislation for Knights Grand Lodge Convention

# Amendment of Grand Statutes, Division I, Chapter XVII, Statute 1.17.011 Members Only Vote

Be it enacted by the Grand Lodge, Knights of Pythias, of the Domain of Oregon, that the Grand Statutes, Division I, Chapter XVII, Statute 1.17.011 which reads:

### 1.17.011 Members Only Vote

Voting in the Grand Lodge shall be confined to members comprising the Legislative Department of the Grand Government. No individual shall be permitted to cast more than one vote.

Be amended by adding, "Additionally, Chancellor Commanders who have served six months of a twelve month term, may apply to the Credentials Committee and receive the right to vote in the next Grand Lodge Convention as a Grand Representative of their lodge." and when so amended and renumbered shall read:

### 1.17.012 Members Only Vote

Voting in the Grand Lodge shall be confined to members comprising the Legislative Department of the Grand Government. Additionally, Chancellor Commanders who have served six months of a twelve month term, may apply to the Credentials Committee and receive the right to vote in the next Grand Lodge Convention as a Grand Representative of their lodge. No individual shall be permitted to cast more than one vote.

# Amendment of Grand Statutes, Division II, Chapter IV, Statute 2.4.01 Election of Officers

Be it enacted by the Grand Lodge, Knights of Pythias, of the Domain of Oregon, that the Grand Statutes, Division II, Chapter IV, Statute 2.4.01 which reads:

### 2.4.01 Election of Officers

The elective officers of a Subordinate Lodge shall consist of a Chancellor Commander, Vice Chancellor, Prelate, Master of Work, Secretary, Financial Secretary, Treasurer, Master at Arms, Inner Guard and Outer Guard, who shall be elected annually or semiannually at the option of each Subordinate Lodge as may be prescribed by its By-Laws. All elections shall be by separate ballot and shall be held at the first regular meeting in December, if held annually, and at the first regular meetings in June and December, if held semiannually, and the term of office shall begin on the first regular meeting night in the month following the election. Provided, however, that the Secretary, Financial Secretary and Treasurer shall be elected at the first regular meeting in the month of December and serve for one year from the first day of January succeeding.

Be Amended by Striking all, replacing with following so that when amended and renumbered shall read:

### 2.4.02 Election of Officers

The elective officers of a Subordinate Lodge shall consist of a Chancellor Commander, Vice Chancellor, Prelate, Master of Work, Secretary, Financial Secretary, Treasurer, Master at Arms, Inner Guard and Outer Guard, who shall be elected semiannually. All elections shall be by separate ballot and shall be held at the first regular meeting in June and December, and the term of office shall begin on the first regular meeting night in the month following the election. Provided, however, that the Secretary, Financial Secretary and Treasurer shall be elected at the first regular meeting in the month of December and serve for one year from the first day of January succeeding.

# Amendment of Grand Statutes, Division I, Chapter I, Statute 1.1.151 Grand Council – Pythian Publication

Be amended by striking all, replacing with the following so that when so 1.1.152 Grand Council - Pythian Publication

### 1.1.152 Grand Council - Pythian Publication

That the Grand Council be and it is hereby authorized and empowered to edit and publish a Pythian Publication at such time as it seems advisable. The cost to print and distribute said publication to this Grand Lodge shall not exceed the sum of Two Thousand Five Hundred (\$2,500.00) Dollars per annum.

### Amendment of Grand Constitution, Article VI, Amendments to Grand Constitution, Section 2

Be it enacted by the Grand Lodge, Knights of Pythias, of the Domain of Oregon, that the Grand Constitution, Article VI, Section 2 which reads:

### Section 2. Procedure

All proposed Amendments to this Grand Constitution shall be signed by a voting member of this Grand Lodge, and submitted in writing to the office of the Grand Secretary at least sixty (60) days prior to the date of the next annual convention. The Grand Secretary shall, at least thirty (30) days prior to the annual convention, forward copies of such proposed Amendments to each subordinate lodge and publish the same in an Oregon Pythian publication, if available. All proposed Amendments as received shall be distributed to committees without further amending. The committees shall forward to the Grand Lodge any amendments to the proposed Amendments at the time of their report to the Grand Lodge. Each amendment so proposed will be decided by the Grand Lodge one at a time. After all reports on the proposed Amendments shall have been received, it will be proper for amendments to the proposed Amendments to be submitted from the floor. (Amended 2002)

Be amended by striking, "each subordinate lodge and publish same in an Oregon Pythian publication, if available." And adding, "each Past Grand Chancellor, Grand Lodge Officer, registered Grand Representative and Lodge Secretary of the Domain of Oregon, at their last known address." So that when amended it shall read:

### Section 2. Procedure

All proposed Amendments to this Grand Constitution shall be signed by a voting member of this Grand Lodge, and submitted in writing to the office of the Grand Secretary at least sixty (60) days prior to the date of the next annual convention. The Grand Secretary shall, at least thirty (30) days prior to the annual convention, forward copies of such proposed Amendments to each Past Grand Chancellor, Grand Lodge Officer, registered Grand Representative and Lodge Secretary of the Domain of Oregon, at their last known address. All proposed Amendments as received shall be distributed to committees without further amending. The committees shall forward to the Grand Lodge any amendments to the proposed Amendments at the time of their report to the Grand Lodge. Each amendment so proposed will be decided by the Grand Lodge one at a time. After all reports on the proposed Amendments shall have been received, it will be proper for amendments to the proposed Amendments to be submitted from the


